A place for affordable, quality care:



On Mission

CentrePointe Client Conditions



CentrePointe provides needed Christian counseling and services in a high-demand area. Clients have sought counseling for stress-related disorders, anxiety, and depression.

According to Mental Health America, 17 percent of Maryland adults had any mental health illness¹ in 2017, compared with 19 percent in Virginia and 21 percent in Washington, DC. This amounted to a combined total of 2.02 million people in the region.

In Maryland, 22 percent of all adults with a mental

illness seeking treatment reported that they were not able to receive the treatment they needed. In Virginia this was 28 percent, and 25 percent in Washington, DC.²

The barriers for individuals seeking treatment include:

- 1. no insurance or limited coverage of services
- 2. overall undersized mental health workforce
- 3. disconnect between primary care systems and behavioral health systems
- 4. insufficient finances to cover costs including co-pays, uncovered treatment types, or when providers do not take insurance

CentrePointe works to overcome all of these barriers. Counseling is made affordable through insurance as well as through need-based grants. Collaboration with clergy, outside counselors, and physicians has resulted in many references. And CentrePointe recruits, supervises, and educates counselors.

Continuing Education

CentrePointe holds monthly Continuing Education seminars, available to practitioners in the area. Continuing Education Units are a requirement of counselors to maintain state licensure. CentrePointe counselors also lecture to church communities and local organizations to inform and build awareness about mental health issues impacting our contemporary context.

The Samaritan Fund

The Samaritan Fund is the mercy grant provided to clients who are unable to meet counseling fees, due to lack of insurance or high co-pay amounts. In FY 2019, over \$5,300 in grants provided care to 11 individuals or couples who could not afford it. Counselors take a reduced fee to see these clients. Additionally, sliding scale (reduced) fees and ministry grants have made counseling available to individuals to help cover the cost of counseling. The Samaritan Fund has great potential to grow and make a bigger impact throughout the region, and will be a targeted focus for fundraising efforts in the future.





¹Any Mental Illness (AMI) is defined as having a diagnosable mental, behavioral, or emotional disorder, other than a developmental or substance use disorder. Any mental illness includes persons who have mild mental illness, moderate mental illness, and serious mental illness.

Client Trends

From July 2018 to June 2019, CentrePointe counselors saw close to 630 clients and couples. Clients found CentrePointe's counselors mainly through family and friends, web searches, and references from insurance companies (a combined total of 65 percent). Clergy, physicians, and other counselors have referred another 20 percent of clients.






Clients come from a variety of faith backgrounds, though primarily Christian. Other than Baptist, the largest representation of Christian clients either do not specify a denomination or are non-denominational.

By far the largest portion of clients pay for counseling services through their insurance. CentrePointe's objective to make counseling financially accessible is reflected in the popularity of our services.

The Samaritan Fund and Ministry Counseling Service grants provide support for those who are unable to afford counseling or are unable to use insurance.

A large portion of clients reside in Montgomery County. The majority of clients reside in the area stretching from the Baltimore area to Washington, DC, and east toward Annapolis.

Financial Update

CentrePointe spent FY 2019 investing in improving its administrative services, so that counselors could serve clients in an updated, informed way and be compliant with regulatory requirements. This accounts for the increased administrative costs for the year.

Total income for FY 2019 was \$1.10 million, an increase of 6 percent from the previous year. This was chiefly driven by an increase in income from counseling and speaking fees (listed as Program Services).

Donors and foundations continued to provide critical support to CentrePointe (Contributions and Fundraising income).

Due to the mission of CentrePointe to provide affordable care by licensed professionals, CentrePointe's counselors attract many clients with limited ability to pay for sessions. Supplementing modest reimbursement returns by health insurance companies, grants and donations provide needed support to maintain quality service, while our church partners provide necessary space for our counselors' practices.

We are grateful for the support of our donors and partners.
